## Malta International Airport - La Valette Competition Terms & Conditions

Last updated on the 30th of October 2018.

By submitting an online form for renewal of your La Valette membership or to book a VIP service online and entering the La Valette Competition, you accept and agree to be bound by the following terms and conditions.

- 1. This La Valette Competition ("Competition") is organised and run by Malta International Airport plc ("Organiser").
- 2. To enter the Competition and be eligible to win, participants must be over eighteen (18) years of age.
- 3. Employees of the Organiser (and their family members) as well as any other persons directly involved or connected with the Competition shall not be eligible to participate in the Competition. Any entries submitted by these parties will be invalid.
- 4. Participants may enter this Competition by submitting an online form for the renewal of the La Valette Club membership or to book a VIP service online.

- 6. The prize will consist of economy class Turkish Airlines tickets departing from Malta (on a return basis) to Istanbul on the Turkish Airlines scheduled route network (MLA/IST/MLA) departing from Malta International Airport ("Tickets"). Relevant class fare conditions shall be applicable.
- 7. When making use of the Tickets, the winner shall receive VIP service through the Malta International Airport VIP Terminal on departure from and arrival to Malta International Airport.
- 8. Transportation of passengers and baggage by Turkish Airlines shall be subject to Turkish Airlines General Conditions of Carriage prevailing at the time of carriage as well as all other applicable rules, laws, regulations and international conventions (such as Montreal/Warsaw) and all and any limitations contained therein.
- 9. The Tickets do not include accommodation, airport transfers, travel costs to and from any airport, or any other cost/expense other than the flight tickets. All taxes, visa costs and any other expenses must be borne by the winner.
- 10. Dates of travel shall be subject to the availability of seats, as shall be determined at the sole discretion of Turkish Airlines. The Tickets are to be utilised by not later than 30 November 2019, and the validity thereof shall not be extended thereafter.
- 11. Bookings are to be made through the La Valette Club at least thirty (30) days prior to the intended dates of travel.

- 12. Seat confirmations are subject to seat availability seat confirmations during blackout dates and peak season are restricted
- 13. Tickets will be valid only on Turkish Airlines operated flights with departure out of Malta
- 14. Tickets have to be used in 2019.
- 15. Once the Tickets are issued, name changes are not permitted.
- 16. One the Tickets are issued, route changes are not permissible.
- 17. The winner will be required to make his/her own arrangements with regards to the necessary travel insurance, visas and other travel documentation required by him/her and any accompanying persons, at his/her own cost. The Organiser accepts no responsibility should the winner, and/or an accompanying person, be unable to obtain the necessary visas and/or other travel documentation to travel to the relevant country.
- 18. The closing date for submission of entries is [28th February, 2019] (the "Closing Date") and any entries received after the Closing Date will not be accepted by the Organiser.
- 19. The Tickets must be taken as offered. No cash equivalent or other alternative prize(s) will be given, except as provided for in these Terms and Conditions, and the Tickets are to be utilized solely for the purpose indicated in these Terms and Conditions.
- 20. Miles and mileage accrual shall not be permitted on the Tickets. The Tickets cannot be used in relation to or in conjunction with a group or tour organised by a travel agent/tour operator.
- 21. There will be only one winner.
- 22. The winning entry will be selected at random electronically on the Closing Date. The winner shall be notified by a phone call provided that sufficient details are provided on the form submitted. Such participant will be asked a skill-based question, which must be answered correctly in order to win the Tickets. The name on the Tickets will be determined by Malta International Airport.
- 23. If the participant with the winning entry cannot be reached by phone within three (3) days, or, is reached but does not answer the question referred to in paragraph 22 above correctly, the Organiser shall draw another form and offer the Tickets to another participant. The process will be repeated, and another form drawn at random, until a winner is found and responds to the skill-based question correctly. The winner will be entitled to the Tickets.

- 24. More than one entry per person is permitted.
- 25. Submission of entries will not constitute proof of receipt and no responsibility will be accepted by the Organiser for entries or acceptances which the Organiser does not receive. The Organiser is not liable for any costs incurred, responses received or any other consequences of error by the participant.
- 26. The Tickets are non-transferrable and non-refundable. The Organiser reserves the right to substitute prize(s) of an equivalent value should the Tickets become unavailable for any reason. If any winner is not able for whatever reason to accept the Tickets, then the Organiser reserves the right to award the Tickets to another participant. Tickets cannot be exchanged for cash or other goods or services or used in conjunction with any other offer or discount.

- 28. The winner will accept and use the Tickets at their own risk. The Organiser will not be liable for any loss (including, without limitation, indirect or consequential loss), damage, personal injury or death which is suffered or sustained as a result or in connection with participating in the Competition and/or acceptance and use of the Tickets. The winner agrees to indemnify and hold the Organiser and all its affiliates and employees harmless from any and all losses, damages, rights, claims and actions of any kind arising in connection with or as a result of participating in the Competition or the winner's acceptance or use of the Tickets.

The winner and any travelling companion agree to participate in any publicity or other such promotional activities, works or materials ("Promotional Works") which the Organiser may reasonably require in connection with the Competition and the Organiser shall have the right to use their names, likeness, image, voice and biographical information for advertising and promotional purposes in connection with the prize promotion in all media without further notice and without the need to make any payment to any person for such use. All rights, including all intellectual property rights of whatsoever description (including registrable and unregistrable intellectual property rights), which vest in the winner and the travelling companion with respect to the Promotional Works, are hereby being irrevocably assigned to the Organiser. - 31. The winner shall procure the travelling companion's agreement to these Terms and Conditions. If the winner supplies to the Organiser personal data relating to the traveling companion, the winner shall be solely responsible for making sure that the provision of such personal data fully

- complies with applicable laws and that the relevant person in regard to whom the data relates has been provided with the Organiser's Privacy Policy available below.
- 32. The decision of the Organiser in awarding the Tickets is final and binding and it shall not enter into any discussion with any participant or other persons regarding the outcome of the Competition.
- 33. The Organiser reserves the right, exercisable at its sole discretion, to cancel or modify the Competition, and to amend any of these Terms and Conditions and/or the prize to be awarded, at any time during the Competition, without the requirement to give any notice to the participants. Participants shall not have any recourse against the Organiser as a result of the cancellation of the Competition or any alterations of the Terms and Conditions and/or the prize.
- 34. If any of the provisions of these Terms and Conditions becomes illegal, invalid or unenforceable in any respect, the legality, validity and enforceability of the remainder of these terms and conditions shall not be affected.
- 35. These Terms and Conditions are governed by and construed in accordance with the laws of Malta. Any dispute in connection with these Terms and Conditions shall be subject to the exclusive jurisdiction of the courts of Malta.
